Applying for a Permit to Carry a Handgun

***** You must already have a Firearms ID Card/SBI# and handgun(s) before proceeding. The FID Card must have a current Long Beach Township or Barnegat Light Borough address. *****

Effective on 12/22/2022 the total fee for Permit to Carry is \$200.00. Two (2) Money Orders are required; \$150.00 payable to "Long Beach Township" and \$50.00 payable to "Treasurer, State of New Jersey".

The following instructions are the same for the initial and renewal application.

1. YOU MUST APPLY IN PERSON

Out of State Resident – apply at a non-toll road State Police Barracks closest to your residence.

In-State Resident – apply to your local police department (State Police patrolled areas apply to local Barracks.)

***PLEASE CALL YOUR LOCAL POLICE DEPARTMENT OR STATE POLICE BARRACKS PRIOR TO APPLYING – DO NOT JUST SHOW UP**

PLEASE PROVIDE THE FOLLOWING AT THE TIME OF APPLICATION:

1. Driver's License and Birth Certificate OR Driver's License and Passport OR Driver's License and Naturalization Paperwork/Green Card.
2. Two (2) State of New Jersey Applications for Permit to Carry A Handgun, form SP642 (Rev. 7/22). Must be double-sided and notarized. A second page 2 is required for the 4th reference. References cannot be related by blood to the applicant and must know the applicant for a minimum of three (3) years prior to the date of the application. The application must be signed and must be notarized on the back.
3. Three (3) color passport-size photographs.
4. Consent for Mental Health Search, form SP066. DO NOT SIGN, it must be signed and witnessed in our presence upon returning the package.
5. Written proof of ownership and qualification with the handgun(s) you intend on carrying.
 - a. Proof of ownership can be a purchase receipt or purchase permit or a notarized letter of ownership listing the make, model, and serial numbers of handgun(s).
 - b. Written qualification must be within six (6) months of application and include the Instructors's Name and Certification, make, model, caliber, and serial number of handgun(s) you intend to carry.
6. Two money orders are required. One in the amount of \$150.00 payable to Long Beach Township and \$50.00 payable to; "Treasurer, State of New Jersey"

7. All applicants (initial and renewal) must be fingerprinted at Identogo. BRING THE IDENTOGO RECEIPT WITH YOUR APPLICATION. Appointment instructions are attached or via www.identogo.com .

c) Contributor Case Number – obtained from the Detective Bureau in person or via email with a copy of the Driver's License

** THE REQUIRED WRITTEN FIREARMS SAFETY COURSE, IN ACCORDANCE WITH N.J.A.C. 13:54-2.4(B), CAN BE OBTAINED AT MOST FIREARM RANGES THROUGHOUT THE STATE. ** A NEW JERSEY PERMIT TO CARRY IS VALID FOR TWO (2) YEARS FROM THE TIME OF APPROVAL.
